### CONTRACT TERMS

Please Read and Initial All Points Below

- A) Non-refundable \$100 administration fee due at signing, prior to draw: X \_\_\_\_\_
- B) Non-refundable deposit of 30% due within 14 business days successful draw: X \_\_\_\_\_
- C) Remaining 70% due before first day of contracted hunt: X \_\_\_\_\_
- D) If for any reason, the Client fails to arrive at New Mexico Outfitter camp as scheduled, no adjustment or compensation will be made: X \_\_\_\_\_
- E) All Deposits/Payments to be made in U.S. Currency (Cash, Bank Check, Venmo, Zelle) unless otherwise specified. X \_\_\_\_\_
- F) Game killed or wounded during the hunt will be considered harvested even if not located. X \_\_\_\_\_
- G) The hunt will be concluded when New Mexico Outfitter considers game has been harvested; see above clause. X \_\_\_\_\_
- H) For Semi Guided Elk Hunts only; a \$1,200 trophy fee will be charged to the client if an Elk is harvested in the 48hr window. X \_\_\_\_\_
- I) Refunds will not be issued for any reason; this includes but not limited to: the client leaves prior to the contracted hunt's end date, New Mexico Outfitter determines that an animal has been harvested (includes killed or wounded, even if not located) prior to the contracted hunt's end date, etc: X \_\_\_\_\_
- J) Arriving earlier or leaving later than the contracted dates, whether hunting or not, will be charged the contracted daily rate for additional days. X \_\_\_\_\_
- K) All game meat will be taken to a processor who will bill directly to the client. New Mexico Outfitter and their guides are not responsible for the transportation of meat past base camp or payment of the processing/donating of said meat. X \_\_\_\_\_
- L) New Mexico Outfitter uses ATV'S and Horses. Helmets will be provided, however New Mexico Outfitter is not responsible for clients' failure to wear appropriate safety gear on any of New Mexico Outfitter ATV'S or Horses . No insurance coverage is provided by New Mexico Outfitter, therefore each client is responsible for his or her own riding risk. X \_\_\_\_\_
- M) Hunters are responsible for supplying their own safety belts, harnesses, and/or any additional safety equipment while using any tree stand or equipment during the hunt. X \_\_\_\_\_
- N) New Mexico Outfitter is not responsible for any injuries or loss of life sustained by the client due to accidents that occur during the duration of the hunt and/or trip. This includes loss or damage of personal property. Client must sign liability release as part of a completed contract :X \_\_\_\_\_
